In 2016, they made \$10,400 and had 250 runners, 42 volunteers, the entire Manchester Football Team plus Town and Park employees. The reason Learn More Center gave it up was because the town cannot support more than one 5k with all the hours of work and large number of volunteers it takes. Weebe did say that she is willing to be on a Planning Committee for fundraising. She recommends holding a raffle like they do at Funfest – maybe for a luxury weekend getaway package maybe consisting of local food, beverage and entertainment. Mel mentioned the first step in this process is to form a Splash Idea Committee. Mel will contact the list of individuals he has to see if they have interest in serving on this committee.
