#### **NEW BUSINESS**

#### **Request for Adaptive Playground Equipment**

Mel read a letter that Julie Garber (Community Foundation) had received from LaTasha Music, a long time North Manchester resident. LaTasha is in the process of adopting a two year old girl with special needs and recently took her to an adaptive park where she had the opportunity to swing for the first time. The swing was for kids age 2-5 and it had full head/back support with a bar that came down over the head and secured between the legs. There was a larger swing for older kids. LaTasha would like to know if we have plans to add adaptive equipment to any of our playgrounds. She is willing to raise funds and apply for grants to make that happen. She also met with Jennifer to discuss and Jennifer offered to look in her catalogs for a estimated cost. The frame and two swings would be around \$5,000 and the area leading to it must be handicap accessible. Jennifer reported that a Pleasant Township Trustee had previously contacted her about having money to donate towards playground equipment. She called and left a message with them to see if that offer still stands. It was suggested to contact Kim Duchane, Adaptive P.E. Teacher at Manchester University, about possible sources of grants we could apply for. Becky mentioned that Wabash has an amazing adaptive park. Jennifer will call and touch base with the Park Director in Wabash to see which equipment gets the most use in that park and will follow up at the next meeting.

Jennifer reported that the Area Five Senior Lunch Program sent a new contract to be signed because they are changing their operational calendar year.
