I attest that this application contains true and accurate information. I understand that eligible family members must reside in the same household. Children may include step and foster children as well as college students ages 18-24 who are eligible dependents on my tax return. NMPR reserves the right to ask for proof of address for each member. I acknowledge receipt of the Member Rules and Regulations Booklet and understand that my membership entitles myself and eligible members of my household to use the facility during normal business hours, pursuant to the terms of the Membership Rules and Regulations Booklet and we agree to abide by the rules/regulations as defined. Any infractions or falsification of information can result in suspension of membership. Applicants under the age of 18 must have a parent/legal guardian sign the application and waiver. I understand that I will receive four (4) Guest Passes with my membership and after they have been redeemed my guests must pay the daily admission rate. If purchasing a membership by Monthly ACH Bank Draft an Authorization Agreement for Automatic Payments must be completed. Monthly payments are deducted on the **second Monday of each month for 12 consecutive months**. Payments must be current to use the facility. A cancellation request for Monthly ACH Bank Draft must be submitted in writing to the Director and if approved, subject to a \$100 Cancellation Fee. If paying by Credit/Debit Card a 3% Processing Fee is charged by PayGOV.US. Checks should be made payable to **NMPR**. Any check or Monthly ACH payment rejected for insufficient funds will be charged an additional \$35 service fee.
